TRADEMARK MONITORING

Once a mark is published in the Official Gazette, trademark owners who may consider certain proposed mark(s) confusing or infringing with their own have thirty days to notify the USPTO of their objections to registration of the mark. If there is no objection to the proposed mark within thirty days, the mark typically becomes registered in the USPTO. The United States Trademark Center, with its proprietary software and customized process for reviewing published word marks, can assist trademark owners by monitoring word marks published in the Official Gazette. The United States Trademark Center provides a trademark owner with information that may be important to maintain its own trademark rights and can allow a trademark owner the ability to oppose marks before these marks become registered. Trademark monitoring is an annual subscription and commences upon receipt of the form below with due payment. Include check or money order for \$ 385.00 US per trademark with form and enclose using the provided envelope.
